# REQUIREMENT COUNTS DO YOU KNOW HOW TO QUICKLY SEE HOW MANY YOUTH HAVE A SPECIFIC REQUIREMENT?

MENU|MISC|REQUIREME NTS|REQUIREMENT COUNTS

- How many you do you have on probation at this moment? Look at requirement counts, and you not only get the total number of every type of requirement, but you get the total number of each probation section for example supervised or unsupervised etc.
- How many owe restitution requirement counts is a quick way to see how many youth owe fees.
- Click on any requirement from requirement counts and a list of those with that requirement will appear by name, start date of requirement, end date and status of the requirement.
- You can select to see only open requirements, or you can see requirements with specific closed status for a date range.
- Click on a person's name and you are directly taken to the requirement and case.
