AMENDING A CHARGE

If during a plea agreement, they agree to amend a charge. You must add the new charge. If they are amending count 1, you will add a count 1A, if they are amending court 2, you will add a count 2A, and so on.

In the Filed statutes section, click on the charge that is being amended.
