It compares all referrals to those who have had an alternative to detention and secure detention. It breaks it down by race and sex and provides a beautiful graph of the results.



Where the data comes from:

The report looks for case names that started during the time period. It then checks the case type that is defined in the report settings as "includeCaseType" to see if that type of case should be included and then checks to see if it has a case status indicating the case should be skipped "skipCurrentCaseStatus."

If all that matches, it looks at the first incident on the case to see if it should be included as defined by "referralIncidentType" or if it should be skipped as defined by "skipIncidentType."

The dates involving this case are reported on the Referral line of the report.

It then looks to see if a facility stay is attached to this case. If a secure location is found it reports the dates on the Secure line of the report.

If a facility stay is found it will check for an Alternative to Detention (ATD) release reason as defined in the report settings as "atdReleaseReason." If that is found it will report the dates on the ATD report line.

The referral line reports all people referred, the ATD and Secure lines report those people where these items were found, and it averages the number of days for each column. It only reports each person once.

<u>Refer to PI</u> – Date of the incident date, ATD Release Date, or Secure Detention start date to the date the Preliminary Inquiry document was completed. The PI Document is defined in the report settings as "piTemplate."

<u>PI to File</u> – Date the Preliminary Inquiry document was completed to the date of the case status that means "filed" in the Table: Case Status.

<u>PI to Dispo</u> – Date the Preliminary Inquiry document was completed to the date of the case status that means "disposed" in the <u>Table</u>: <u>Case Status</u>.

<u>File to Dispo</u> – Date of the case status that means "filed" to the date of the case status that means "disposed."

<u>Refer to Dispo</u> - Date of the incident date, ATD Release Date, or Secure Detention start date to the date of the case status that means "disposed."
