Detention statistics

This report looks at the locations selected in the report criteria and finds facility stay locations that were open at some point during the date range. These facility stay locations are the "Referrals" the report is talking about.

1. – New Referrals by agency:

This section is reporting the referring agency on the Facility Stay Reason Detail that is less than or equal to the start of the location.

2. – New Referrals per month:

This section reports how many new referrals or new locations there were by month. If you ran the report for a year you could compare the different months.

3. New referrals per hour:

This looks at how many new facility stays were open each hour. Gives you a sense of when your busy times are.

4. Age of new referrals:

This section reports the age of each person with a new location during the time period.

5. New referrals total times referred (recidivism)

For each of the new referrals it is reporting, it is giving the total number of referrals that person has had.

6. Ethnicity of new referrals

Simply reporting the ethnicity of each new referral.

7. Current school assignment of new referrals.

Reports which school they were attending at the time of their referral.

8. Bed days per month.

If they are in a specified location for any part of the day it counts them. It then reports for each month how many people were in a location during the day.

9. Average daily population per month

This section looks at the bed days per month and averages them.

10. Chargeable bed days per month.

This is looking at the report settings "morningCutoff" and "eveningCutoff" to determine if a person should be charged for an entire day. They must be in a location by the morning cut off time to be counted or they must be in a location as of the evening cut off time to be counted for that day.

For example, if your cut off times were 6:00 am and 8:00 pm.

Somebody comes in on Sunday at 9:00 pm they won't count on Sunday but if they are in on Monday at 6:00 am they count for Monday. If they are released Monday at 5:00 am, they won't count on Monday.

Someone comes in on Sunday at 7:00 pm and leaves on Monday at 7:00 am, they Count on Sunday and they count on Monday.

If they come in at 7:00 am and leave at 5:00 pm they don't count because they weren't there for either morning or evening cut off times.

11. Average chargeable daily population per month.

Using the chargeable days and averaging them per month.

12. Post disposition bed days per month.

The disposition date comes from a commitment requirement as defined in the report settings "commitment." If it finds a commitment requirement that is after the start of the stay and before the end of the stay it is considered a post disposition bed day.

13. Average post disposition daily population per month.

Looks at the post disposition bed days and averages them for the month.

14. Average length of stay during period.

It looks at the length of stays that occurred during the reporting period and averages them.

15. Average people per day.

This section looks at the bed days for the reporting period and averages them.

16. Average length of stay for people released during period.

It looks at the people released during the reporting period, calculates how long they stayed, then averages them.
