Where the data comes from:

The report will go through the open cases as defined in the report settings, "delinquencyCaseType" and "dependencyCaseType" to determine if a person has at least one of each.

In those cases, such as JM, which could be either a delinquency or dependency case, as defined in the report setting "couldBeEitherCaseType" the report will check the severity of the incident or filed statute as defined in the report setting "dependencyStatuteSeverity" to determine in which group it should be included. In Indiana the JM case type is used for an informal adjustment in both delinquency and dependency. If a statute is not found, it will be reported as a delinquency.
