



When you have finished getting the email links, you can click the **Cancel** button to get out of the signature portion of the document.

It doesn't matter who signs first, each link will go to the appropriate signature spot. If the person clicks on the link and the signature box is not over their signature space, they can click the **Next Signature** button to position the box over the correct signature line.

When a person clicks the link a browser window opens up to that document with their signature spot highlighted. They sign their name then click the **Update** button.
