What it does:

These functions all work together to product the charging paragraphs for Delinquency Petitions. You select the petition you wish to process, then the charging template is pulled into the current document, the count, statute name with class and level of severity, and the state code for that statute are all displayed in the document.

FF CHG CNT/00 – Format charge count for petitions

This function formats the count (i.e. 1, 2, 3a, etc.) for display on a petition. In addition, it will also show a prompt screen showing the count that is being processed.

FF CHG DSC/00 – Format charge description for petitions

This function formats the description of a statute for display on a petition.

FF CHG DSC/01 – Format charge level/severity for petitions

This function formats the level and severity of a statute for display on a petition.

FF PTNCHG/00 -Format N-A variables with incident charges

Formats the N-A @F/ variables with the charges associated with the first petition tied to the document.

FF PTNCHG/01 -Format N-A variables with petition charges

Formats the N-A @F/ variables with the charges associated with the latest incident tied to the first personID/caseID tied to the document.

FF CHG STA/00 -Format state code for petitions (w/Common Law)

This function formats the state code from the statutes table of a statute for display on a petition. If the statute has conspiracy/attempt/aid specified, and 'CL' or 'common law' isn't part of the state code, then ' and Common Law' will be added to the state code.

FF CHG STA/01 –Format state code for petitions (only Common Law)

This function formats ' and Common Law' of a statute for display on a petition if neccessary. It is only added if the statute has conspiracy/attempt/aid specified.

FF CHG STA/02 –Format state code for petitions (no Common Law)

This function formats the state code from the statutes table of a statute for display on a petition.
