FF PETNS/00 – Select petitions

Allows the selection of one or more petitions to tie to the document. The petitions listed will be those petitions associated with the cases tied to the document.

FF PETNS/01 – Select a single petition

Allows the selection of one petition to tie to the document. The petitions listed will be those petitions associated with the cases tied to the document.

FF PETNS/02 – Automatically selects first petition

Automatically selects the first petition to tie to the document. The petition selected will come from a case tied to the document.
