

Rule GAW021 – Warrant Notify

Apply when: Warrants database file

Subtask: d

Standard GAWDBObject subtasks:

'C' - on object creation

'R' - before referential integrity

'i'/'I' - before/after insert

'u'/'U' - before/after update

'd'/'D' - before/after delete

Sequence: 4 (Controls the order in which rules will be applied for a given subtask)

Java class:*

This rule is will send eQuest messages to specified Identities when a Warrant is added/updated. The purpose is to notify certain parties like the Sheriff who must know when Warrants are issue, served, recalled, etc. Messages are intended to be sent when a new Warrant record is added or when the warrant status is changed. Messages will be sent to all persons specified in the RuleParms entry of the defaults table.

Valid properties are:

WarrantNotify.userID.n=<Quest userID>

WarrantNotify.email.n=<email address>

this will send a message to the Quest user or email specified.

It should be called after insert, before update and before delete of the Warrants database file (I, u, d).

Rule Setup:

Apply when	Sub-task	Seq	JAVA class
<u>Warrants</u>	d	4	equest.rules.WarrantNotify
<u>Warrants</u>	I	4	equest.rules.WarrantNotify
<u>Warrants</u>	u	4	equest.rules.WarrantNotify

Rule Parms:

WarrantNotify.userID.1=todstu





WarrantNotify.userID.2=shaarm

WarrantNotify.email.1=gnewman@madisoncountyttn.gov

This rule will notify the people when the warrant screen changes. For example, I'm adding a warrant to Laura Ingalls.
