IV-D Reimbursement Invoice

In Tennessee, the Department of Human Services administers the Child Support Program. Offices are located across the state in all 31 Judicial Districts. The services are provided through local district attorneys, DHS staff and private agencies.

The Child Support Program provides services that promote parental responsibility to meet the financial needs of children and their families.

Title IV-D of the Social Security Act requires all states to have a child support program. The Child Support program is sometimes referred to as the IV-D program. If you receive services from your local child support office, your child support case is a IV-D case.

36-5-117. Reimbursement of clerks of court for activities involving child support, central state case registry and the central collection and disbursement system.

(a) (1) Notwithstanding any law to the contrary, and in lieu of any other fees or costs set forth by law that would otherwise be applicable to cases enforced by the department of human services or its contractors pursuant to Title IV-D of the Social Security Act (42 U.S.C. § 651 et seq.), and for activity related to the collection and disbursement of support in cases subject to 42 U.S.C. § 654b, and for their activities required pursuant to § 36-5-115, the clerks of court shall be reimbursed by the department to the maximum extent permitted under federal law and regulations for the actual costs of providing services for which federal financial participation is available for child and spousal support cases being enforced pursuant to, or otherwise subject to, the requirements of the Title IV-D child support program.

IV-D Documents

When a IV-D document is scanned into Quest, the document will add a requirement called "IV-D Reimbursable Expenses". These are transactions and not assessments. These transactions are under the Respondent's name.

The document will ask you questions, such as what type of document is being filed and if you need to add copy fees.

IV-D Invoice

At the end of the month, you run a report called "Clerk IV-D Reimbursement Invoice." The report will ask if you wish to "Create final invoice assessment: Y/N" If you answer yes, it will create the invoice. Every IV-D transaction made during that month will be included in the report.
