**Case assignments:** This section tells how many cases have had this person assigned to them, including inactive assignments.

**Case represents (person ID):** This tells how many case assignments for this person indicated they represented someone.

**Case counts:** I have no idea what this means.

**Emergency contacts:** This indicates how many emergency contact numbers are listed in this Person Detail.

**Messages:** This is how many Quest messages this person currently has.

**Documents (documentStatusID):** This is how many documents this person has created in Quest.

**Event appearances:** This is how many times this person has been marked as having appeared at an event.

**Event names:** The number of events this person's name has been included in.

**Notices:** This is how many notices sections of the document detail screen this person has added.

**Aliases (PersonID):** This is how many aliases are listed on this person's detail screen.

**Contacts (personID):** This is how many contact notes are listed under this person's name.

**Contacts (workerID):** This is how many contact this person has made on other people's names.

**Supervision levels:** This is how many different supervision levels are on this person's caseload. **Nope, she has more than that.**

**Facility stays (releasedByID):** How many facility stays were released by this person.

**Stay reasons (releasedByID):** How many stay reasons in the facility stay were released by this person.

**Visitors (visitorID):** To how many people is this person listed as an authorized visitor.

**Visits (visitorID):** How many visits has been logged for this person?

**Incident officers (officerID):** How many incidents list this person as the officer?

**Case notes (workerID):** How many case notes have been made by this person?

**Identity miscellaneous:** No idea.

**Group members:** How many message groups include this person.
