
Open people by court

The report will search for open case types that match the report settings "caseType" and look at each name associated with the case.

It will look at the age of that person and determine if they are over 21. If so, it will put the person in that section. If that person also has another case where their name is open, and that case is from another defined case type it will report this person in the overlapping section.

If the overlap is from the same group (two delinquency cases) they will only appear in the report once. However if the overlap is from different groups (a delinquency and a paternity) their name will appear in each group (juvenile, family, overlapping).
