

Open warrants

Report Description:

This report will list all open warrants. You can limit this list by warrants issued after a specific date, type of warrant, or court. It will display identifying information on the person, including address and phone numbers, the case number, charges, and next event.


Running the Report:

From date – if you don't put in a from date, all open warrants will be listed, otherwise only those issued since the date you entered will be listed.

Warrant type – Select the type of warrant you wish to view. If you don't select a warrant type, all warrants will be listed.

Limit to court – If you select a court, only those open warrants for a specific assigned/home court will be listed.
