

1006 DOC Requirements reporting


Report Description:


This is a community corrections report. It will search for specific requirements then report demographic information on the individual, such as name, dob, ssn. It also reports the most serious offense the individual was charged with, the specific requirement name, start date, end date and type of completion. It was also provides the employment status of that person on the last day of the requirement period.

Running the Report:

Where the data comes from:

The report searches for the requirement code(s) to report as defined in the report settings “[requirementCode](#).” If the requirement was open at the beginning of the date range submitted the report will provide information on that person and case. The first 5 columns are reporting information from the identifying information of the person.

- **HLOS** = The most serious offense an individual has been charged with.
 - This is being pulled from the Filed Statutes in the case where the program requirement was found. It lists the severity of the most serious offense.
- **LOSPROG** = field specifying the 1006 funded Level Of Supervision/Evidenced Based Cognitive Program/Service the individual participated in.
 - This is listing the program requirement specified in the report settings “[requirementCode](#).”
- **STDT** = The date a participant started the Level Of Supervision/Evidenced Based Cognitive Program/Service.
 - This is the start date of the program requirement.
- **ENDDT** = The date a participant completed (successfully or not) the Level Of Supervision/Evidence Based Cognitive Program/Service.
 - If the program requirement has a “closed” requirement status and status date, it will list the status date.
- **CSTAT** = A two letter variable defining a participant’s type of Level Of Supervision/Evidence based Cognitive Program/Service completion. All Level Of Supervision end types should be recorded. AA – Active, CC – Completed, NC – Did not complete.
 - If the requirement is still open this column will display AA.
 - If the requirement is closed with a successful requirement status, this column will display CC
 - If the requirement is closed with an unsuccessful requirement status, this column will display NC.
- **EMPSTAT** - The status of employment on the end date of the Level of Supervision/Evidenced Based Cognitive Program/Service. Legal employment is considered any employment resulting in the withholding of taxes.
 - If an employer is found with an employment status that means “employed” this column will display a Y, otherwise it will display a N.
