

Seal Cases of People Over Age

Report Description:

This report will search for specific case types and search the names associated with the case to determine if all are over a specified age. If so, it will seal the case. It can also add a person or case attribute indicating it has sealed a case. It will provide a report that informs you of those people and cases found.

Running the Report:

This report does not require any input.

Seal Cases Of People Over Age
Enter report criteria and press "Submit"

This report does not require any additional input. Press "Submit" to submit the report for execution.

The Report:

The report will provide a list of names and cases found where all names associated with the case were over the specified age.

Where the data comes from:

This report will search for the specific case types specified in the report settings under “caseType”. It will then check to see if everyone in that case is over the minimum “age”. If so the report can add a case attribute and/or a person attribute to indicate the person has a sealed case. Plus the report will seal the case. Only those with authority to view “sealed” cases can see it.
