Required Quality Statewide Data Collection

37-1-187. Quality Statewide Data Collection.

(d) Each juvenile court, through the juvenile court clerk or juvenile court staff, shall, each month, in a format prescribed by the administrative office of the courts, report to the administrative office of the courts the following information:

(1) Each new delinquent case or unruly case in which a child is charged, including:

(A) The date the case was filed or opened; (*Case Status*)

(B) The statutory offense or offenses charged; (*Filed Statutes*)

(C) The child's unique child ID number; (*File Number*)

(D) The unique case or docket number, which shall not be the child's unique child ID number; and (*Case Number*)

(E) The child's name, date of birth, race, sex, ethnicity, and social security number; and (*Person Detail*)

37-1-187. Quality Statewide Data Collection.

(2) For each case reported pursuant to subdivision (d)(1), the following information, as applicable, along with the unique case or docket number:

(A) For cases that result in diversion, the date the child was placed on diversion, the type of diversion, the ending date for the diversion, and whether the diversion was successfully completed; (*IA, PTD, JD Requirement*)

(B) The date the child was adjudicated delinquent or found unruly, and on which offenses, or the date the case was dismissed; (*Filed Statute Disposition*)

(C) For cases in which the child was adjudicated delinquent, the date the child's validated risk and needs assessment was completed pursuant to § 37- 1-164; (*Supervision-Assessments*)

(D) The date the case was closed, transferred to another juvenile court, transferred to the criminal court of competent jurisdiction, dismissed, or otherwise disposed of; (*Case Status*)

(E) For cases that result in probation, the date the child was placed on probation, the type of probation, the ending date of the probation, and whether the probation was successfully completed; (*Requirements*)

(2) For each case reported pursuant to subdivision (d)(1), the following information, as applicable, along with the unique case or docket number:

(F) For cases that result in a court-ordered out-of-home placement, the date of the out-of-home placement, the type of out-of home placement, and the ending date of the out-of-home placement; (*Requirements*)

(G) Any post-adjudication detention ordered pursuant to § 37-1-131 (a)(3), including the length of detention ordered; and (*Requirements*)

(H) For cases that result in a petition alleging a probation violation, the date the violation petition was filed, whether the violation petition resulted in diversion or adjudication, the date of the diversion or adjudication, the type of diversion or, if there was an adjudication, whether the violation was sustained or dismissed. (*Filed Statutes*)

Data Trends

- Missing SSNs
 - Perhaps hardest statistic to collect
 - DCS cases no information listed
 - Advice/tips on how to follow up to collect SSNs?
- Closing cases
 - Cases nulled/dismissed disposition yet case history shows case still open
 - Dismissals due to successfully completing diversion/probation
 - Diversion cases open after diversion period ends
 - Closing out requirements correctly
- Statute errors
 - JD, JS, JM, TRF, or D&N??
 - Possibly wrong click when creating case??
 - “Other” filed statute
- Disposition/Requirements
 - Diversions not listed in both areas
 - Guilty dispositions but no requirements?
 - Probation?
 - Correct D&N Dispositions/Requirements
 - Granted vs. Guilty
 - DCS D&N Custody or transfer custody to relative??
- Validated Risk/Needs Assessments
 - Issues getting assessments from DCS??

Discussion/Helpful Tips/Advice?

- SSNs
 - Arraignment/Initial Appearance letter contains language asking families to bring SSNs
 - Fillable Information sheets for families before hearings
- Proofread your cases thoroughly
 - How are you updating your cases in Quest?
- Open discussion for meeting
